## RESOLUTION BY TOWN ELECTORS TO ENDORSE THE TOWN BOARD'S RESOLUTION TO EXCEED THE LEVY LIMIT

## Town of Eaton, Manitowoc County Resolution No. 2022-4

Whereas, the State of Wisconsin has imposed levy limits on town tax levies for 2022 and thereafter under Wis. Stat. § 66.0602;

Whereas, Wis. Stat. § 66.0602(5) allows the town electors in a town with a population of less than 3,000 to exceed the maximum allowable levy limit by adoption of a resolution at a town meeting of the town electors;

Whereas, the town board has adopted a resolution supporting an increase in the town tax levy which would exceed the maximum allowable state levy limit for the Town of Eaton;

Whereas, a special town meeting of the town electors has been called and properly noticed to consider the adoption of a resolution to endorse a town board resolution to exceed the state levy limits, specifically by increasing the allowable town tax levy for 2022 (to be collected in 2023) by 19.33%;

THEREFORE, the special town meeting of the Town of Eaton, Manitowoc County, Wisconsin, by a majority vote of the eligible electors duly assembled and voting on this 2<sup>nd</sup> day of November, 2022, hereby resolves and orders as follows:

- 1. The town electors of the Town of Eaton, Manitowoc, Wisconsin endorse the town board resolution to increase the town tax levy for 2022 (to be collected in 2023) by 19.33% over the allowable 2022 levy, which is a dollar increase of \$49,911 over the allowable 2022 town tax levy. The amount (\$23,703 for the one year payment of the plow truck) and (\$26,208 for the one year cost of the ambulance) The board felt it was advantageous for the levy to be increased to also include the one year ambulance cost to alleviate decreasing the amount of money for the Town road construction budget.
- 2. The town clerk shall properly post or publish this resolution as required by law under Wis. Stat. §

60.80(1)(a) within 30 days after its adoption.

## RESOLUTION OF TOWN ELECTORS TO ADOPT TOTAL TOWN TAX LEVY AT SPECIAL TOWN MEETING OF TOWN ELECTORS

## Town of Eaton, Manitowoc County Resolution No. 2022-5

Whereas, Wis. Stat. § 60.10(1)(a) authorizes the town electors of a town to adopt the town tax levy at a town meeting of the electors;

Whereas, a special town meeting of the town electors has been called and properly noticed to approve the 2022 total town tax levy (to be collected in 2023), pursuant to Wis. Stat. § 60.10(1)(a);

Whereas, the town electors, after proper notice, have, via a special town meeting vote, authorized the Town of Eaton to exceed the allowable state levy limit;

THEREFORE, the special town meeting of the <u>Town of Eaton, Manitowoc County</u>, Wisconsin, by a majority vote of the eligible electors duly assembled and voting on this 2nd day of November, 2022, hereby resolves and orders as follows:

The town electors of the <u>Town of Eaton, Manitowoc County</u>, Wisconsin adopt the total town tax levy for 2022 (to be collected in 2023) in the amount of <u>\$308,141</u>. The 2021 payable 2022 adjusted actual levy is \$258,696. And further, whereas the state law would limit the increase to \$1,112.39 for an allowable town tax levy of \$258,230 before adjustments and 281,933 including debt adjustment of \$23,703 for the snow plow truck payment, for 2022 collected in 2023, and the increase of the town tax levy for 2022 to be collected in 2023 which would increase the town levy by \$26,208 for ambulance costs, for an allowable total town tax levy of \$308,141

1. The town clerk shall properly post or publish this resolution as required by law under Wis. Stat. § 60.80(1)(a) within 30 days after its adoption.
